- Representative medical negligence and serious injury cases
  - Second chaired a \$5,700,000 jury verdict against a medical clinic for failure to diagnose breast cancer
  - Worked with co-counsel to negotiate a \$1,350,000 settlement for the families of two women killed by a drunk driver who was overserved at a local bar
  - Won a \$537,176.45 jury verdict against a local hospital system on behalf of a woman who suffered a nerve injury during a blood draw
  - Negotiated numerous confidential settlements in medical negligence and serious injury cases
